The Secretariat of the International Atomic Energy Agency (IAEA) presents its compliments to the IAEA's Member States and has the honour to draw their attention to the Educational Workshop for **Permanent Mission Representatives on the Convention on Nuclear Safety** (hereinafter referred to as "event") to be held at the IAEA's Headquarters in Vienna, Austria, on 8 July 2024.

The purpose of the event is to provide Permanent Mission representatives with an introduction and overview of the Convention on Nuclear Safety (CNS), its obligations and the peer review process, as well as the adherence process to the CNS.

The IAEA also does not provide health insurance coverage for participants in IAEA events. Arrangements for private insurance coverage on an individual basis should therefore be made. The IAEA will, however, provide insurance coverage for accidents and illnesses that clearly result from any work performed for the IAEA.
