I am pleased to inform you that the International Atomic Energy Agency (IAEA) is organizing the above event under the IAEA technical cooperation project RER9163, "Improving the Protection of Workers Exposed to Radiation at Naturally Occurring Radioactive Material Sites".

The purpose of the event is to review the progress made and achievements reached, share experiences on lessons learned and best practices under the technical cooperation project RER9155 "Enhancing Regulatory and Methodological Infrastructures Needed to Ensure Radiation Safety in Naturally Occurring Radioactive Materials Industry", discuss and make arrangements for the implementation of activities under the succeeding TC regional project RER9163.

The attached Information Sheet provides further details, including technical and administrative aspects of the event. Selection of participants will be in accordance with IAEA procedures. Member States are strongly encouraged to identify women participants.

Travel details will be agreed with the participants upon receipt of their official nomination. Participants will also receive an allowance from the IAEA sufficient to cover their costs of lodging, daily subsistence and miscellaneous expenses for the duration of the event in line with IAEA rules and procedures.
